Recognition Order

Whereas, in terms of Section 15(1) of the NCTE Act, 1993 M.J. College, Kh. No. 2038, 2039/1 Khohka Junwani Road Bhilai Nehru Nagar Bhilai, Durg, Chhatisgarh has submitted an application (Code No. APPWRC191) to the Western Regional Committee of NCTE for grant of recognition/permission of additional intake in existing B.ED. course with an annual intake of additional 100 students on 30.10.2009.

And whereas, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the SC teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

Now, therefore, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition / permission to M.J. College, Kh. No. 2038, 2039/1 Khohka Junwani Road Bhilai Nehru Nagar Bhilai, Durg, Chhatisgarh for conducting B.ED. course of Secondary Level of 1 year duration with an annual intake of additional 100 Hundred seats from academic session 2010-2011 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulation 2009 making total intake 200.

The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011, failing which the recognition will be effective from the academic session 2011-2012.

The recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session be fulfilled as per calendar of the University/Affiliating Body.

Post recognition condition are as under :-

- (i) The institution shall comply with the various other Norms and Standards prescribed in the NCTE Regulations, as amended from time to time.
- (ii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 3(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- (iii) Further, the institution should fulfill all such other requirements as may be prescribed under relevant norms and standards of NCTE or other regulatory bodies like UGC, the State Government etc., wherever applicable.

- (iv) The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- (v) If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- (vi) The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- (vii) The society sponsoring the institution shall be required to transfer the title of the land and building in the name of the institution within a period of six months from the date of issue of this order under sub regulation (11) of Regulation 7. However, in case, the society fails to do so due to local laws or rules or bye-laws, it shall intimate in writing with documentary evidence, of its inability to do so.
- (viii) The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
- Copy of the Application Form
 - Land and Building Particulars.
 - Staff Profile.
 - Recognition letter.
 - Information for having fulfilled the norms & standard and other required conditions.
